Executive Summary

This Notice informs Members of the appointment of an additional Designated Market Maker ("DMM") in Pack and Bundle strategies in the Three Month Euro (EURIBOR) and Three Month Sterling (Short Sterling) Interest Rate Futures Contracts.

1. London Notice No. 3258, issued on 26 February 2010, informed Members of the appointment of Designated Market Makers ("DMMs") in Pack and Bundle strategies in the Three Month Euro (EURIBOR) and Three Month Sterling (Short Sterling) Interest Rate Futures Contracts (respectively "Euribor Packs and Bundles" and "Sterling Packs and Bundles"), effective from 1 March 2010.
2. **Subject to the completion of legal agreements**, this Notice provides Members with an updated list of DMMs in Euribor Packs and Bundles and Sterling Packs and Bundles. These DMM arrangements will remain in place until the close of business on **Tuesday 31 August 2010**. The appointment of the DMMs is subject to standard contractual terms (e.g. in respect of early termination).
