APPOINTMENT OF A PRIMARY LIQUIDITY PROVIDER AND COMPETITIVE MARKET MAKER

Executive Summary

This Notice informs Members of the appointment of a Primary Liquidity Provider and Competitive Market Maker for certain UK Individual Equity Option Contracts on and from 14 March 2011.

1. London Info-Flash No. LO10/17, issued on 17 June 2010, invited Members to apply for participation in the Primary Liquidity Provider ("PLP") and Competitive Market Maker ("CMM") Schemes in respect of UK Individual Equity Options ("UK IEOs").
2. **Subject to the completion of legal agreements**, this Notice confirms the appointment of **MMX Trading B.V.** as an additional CMM and PLP for the remainder of the current Schemes (i.e. until the close of business on 30 June 2011). Such appointment is subject to standard contractual terms (e.g. in respect of early termination).
3. A full list of the UK IEOs for which this PLP/CMM has been appointed forms the Attachment to this Notice.
