Executive Summary

This Notice provides Members with the current list of Nominated Warehouses and Nominated Warehousekeepers for the Storage of Cocoa and Robusta Coffee and provides information in relation to Nominated Warehouses and Nominated Warehousekeepers following the annual re-registration process.

1. In accordance with procedure D 1.1.2(c) of the Grading and Warehousekeeping Procedures in respect of Cocoa and Robusta Coffee Futures Contracts, the Exchange is required, from time to time, to publish a list of Nominated Warehouses and the Nominated Warehousekeepers thereof ("the List"). This Notice advises Members of the following updates to the List.
2. Following the annual re-registration process, the following Warehousekeepers did not apply for renewal and have therefore been removed from the List:
 - (i) Port Cargo Services LLC, nominated for the storage of Robusta Coffee in the Port of New Orleans; and
 - (ii) Henry Bath Italia, nominated for the storage of Robusta Coffee in the Port of Trieste.
3. Members are further advised that the following Warehousekeepers have changed their names:
 - (i) Sitos Commodities (Amsterdam) BV and CWT Commodities (Amsterdam) BV, nominated Warehousekeepers in the Delivery Area/Port of Amsterdam, will now be nominated under the single name of CWT Commodities (Amsterdam) BV. Accordingly, Sitos Commodities (Amsterdam) BV will be removed from the List;
 - (ii) C. Steinweg NV, nominated for the storage of Cocoa/Robusta Coffee in the Delivery Area/Port of Antwerp, will now be nominated as C. Steinweg Belgium NV;

- (iii) Genoa Metal S.r.l, nominated for the storage of Cocoa/Robusta Coffee in the Port of Genoa, will now be nominated as C. Steinweg – GMT S.r.l;
- (iv) HD Cotterell (UK) Ltd, nominated for the storage of Cocoa in the Delivery Area of Humberside (including Hull), will now be nominated as AGC (Commodity Store) Ltd;
- (v) Norfram Engelbrecht SA, nominated for the storage of Cocoa/Robusta Coffee in the Delivery Area/Port of Le Havre, will now be nominated as Manuport Logistics Engelbrecht; and
- (vi) Sitos Commodities (UK) Ltd, nominated for the storage of Cocoa/Robusta Coffee in the Delivery Area/Port of London, will now be nominated as CWT Commodities (UK) Ltd.
