**CHANGES TO EXCHANGE AND CLEARING FEES FOR TRADES EXECUTED IN CERTAIN EQUITY CONTRACTS****Executive Summary**

With effect from 3 November 2014, and ahead of the migration of Liffe Equity Contracts (the "Contracts") to ICE Futures Europe, the Exchange and Clearing fees and fee caps for trades executed in certain Equity Contracts will change.

1. Ahead of the migration of the Liffe Equity Contracts to ICE Futures Europe, the Exchange will make amendments to the Exchange and Clearing fees as well as the fee caps in certain Equity Contracts.
2. The changes to the fees bring into line the combined Exchange and Clearing fees for trades executed on the Central Order Book and those published on Bclear.
3. The Attachment to this Notice sets out the current and revised fee structure for the specific Contracts.
4. Fees and fee caps for all other Equity Contracts not mentioned in the Attachment remain unchanged.
